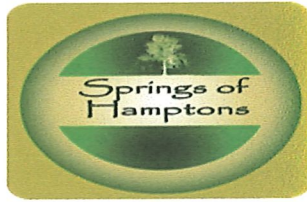

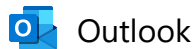

The Warren Township Development Association heard this petition on May 8, 2025. Our board **supports** this project and the variance **unanimously**.

The National Road coming through our township, in 1954 the first Cloverleaf intersection in Indianapolis was built on this road and Shadeland Avenue. The Cloverleaf was needed to ease the traffic from all the industries in Warren Township. (Ford, Chrysler, Western Electric, International Harvester). In 1955 Eastgate Shopping Center was built as the first shopping mall in Indianapolis. Eastgate is to the north of this location. The decline starts in the 1970's as factories close or relocate. In 1980 Cub's Foods, a new concept in grocery shopping, is built and opens, just west of this property in question. Eastgate Mall becomes home to Homeland Security, IMPD East Post and Lifeline Data Center. Development and renewal of this area has ceased since the 1980's. This area has been basically stagnating of development since this timeframe.

This project may be what is needed to help us rise like a phoenix from lack of development. Wawa brings the bright and shiny of new construction to the gateway of Warren Township proper. These employee-owned locations are clean and well-run businesses. These are NOT 2 employees 'gas and cigarette' stands. Wawa has 8 to 10 employees per shift.
